As we begin a new year, we encourage you to take some time to update any contact information that may have changed recently. This information could be your mailing address, phone number, e-mail address, etc.

Did you know that you have the ability to update your contact information 24/7 in It's Me 247 Online Banking and in our Mobile App? Simply login and find the "Info Center" tab and click on "Personal Information" where you can edit your address, phone number, e-mail address and setup a code word.

BAD ADDRESS FEE

It is very important that you update your address with us in a timely manner. With our upgraded system, bad addresses are flagged with returned mail and for every account that you have with us (i.e. Savings, Checking, Christmas Club, etc), you will be charged \$5.00 per account per month for a bad address. This fee is in place to encourage our members to update their address with us ASAP so that we can ensure we are sending monthly statements and other important notices to the correct location.

If you have a VISA® Credit Card with us, you may be eligible to skip your minimum payment for February 2021. We realize that you may need extra money at the beginning of the year and we want to help in any way possible. The Skip-A-Pay will be available for both our VISA® Classic and VISA® Platinum cards. On your January 2021 statement, the "Minimum Payment" box will be replaced with the words "SKIP PAY" for all eligible credit cardholders.

If you are eligible to skip your February payment, you will not need to turn in any paperwork if you choose to participate. However, please know that you do not have to participate in the Skip-A-Pay Promotion. If you would like to make your minimum payment for the month of February, you will find that payment amount on the top right-hand corner of your January statement. For any questions about this promotion, please contact either of our branches.

+Restrictions do apply. Interest will continue to accrue on all skipped loan payments. All accounts must be current and in good standing to qualify.
