We're excited to share that on July 25, 2022 our Debit Cards will be going through an upgrade. We know you probably have some questions so we have answered a few below:

Frequently Asked Questions

Will I get a new Debit Card for the upgrade? You will keep your current SCCU Debit Card with the same card number and expiration date until that card is set to expire. When that card is reissued, you will still keep the same card number unless it is reissued due to fraud. However, when you do receive a new Debit Card, it will have a new look!

Will I still use CardValet® for my SCCU Debit Card(s)? Our CardValet® App is going away in late summer of 2022, but we are replacing it with Card Controls. This will be accessed using your Santee Cooper Credit Union Mobile App. With Card Controls, you will have the ability to turn your SCCU Debit Card on/off and receive transactional notifications to your mobile device.



Will we have any new services with the Debit Card

Upgrade? Yes, we are adding Digital Wallets, which is anticipated to be available by the fall of 2022! This new service will give you the ability to add your Santee Cooper Credit Union Debit and Credit Card to your smartphone's wallet as a payment method, which can be used for in-store as well as online purchases. We are planning to add digital wallets for use with Apple Pay, Samsung Pay and Google Pay.
